I What data do we process?

Your personal data and in general all information that is shared with us.

Your data is valuable: don't give us unnecessary data!

Why do we treat them?

I Why can we do that?

Data Processing is lawful when:

contract: it is necessary to execute a contract referred to in

Interested party or pre-contractual measures requested by the interested party

Consent: The interested party expresses its consent in a free, specific informed and unequivocal

legal obligation: it is necessary to fulfil a legal obligation the Data Controller is subject to

legitimate interest: it is necessary to pursue the legitimate interest of the Data Controller or third

parties protection of vital interests: is carried out to preserve serious and current dangers to the

life of the Data Subject public interest: it is necessary to carry out a task in the public interest or to

exercise public authority

How do we use them?

We take appropriate security measures to protect your data and process them according to the law. (Articles 13 and 14 of the GDPR)

Who do we share your data with?

With those who help us to do our job and achieve the stated purposes (employees, consultants, collaborators, external professionals, consulting companies and our suppliers as those who manage the operation of the tape IT system, etc)

With the categories of subjects specifically indicated in the extended information accompanying this document.

How long do we keep your data?

We retain the data for the minimum time necessary to achieve the purposes,

We keep them longer only if it helps to comply with legal obligations, fulfil orders from public authorities, or pursue a legitimate interest (such as exercise or defend a right in question)

Important If your consent is required (for marketing purposes, for example), we process your data as long as you agree. In fact, you can revoke your consent to data processing at any time by giving us notice (opt-out), but in that case we may no longer be able to provide you with certain activities and/or services.

Where do we find them?

You give them to us!

We can give them to third parties, instructed by you (e.g. who asks us a service for you) or by noir Some data is collected automatically (e.g. navigation data) We may also get it from public registers and other sources accessible to the public
